2. **All interested Persons/bidders are requested to register their name before 11:30 AM by paying and deposit Rs.200/- (Rupees Two Hundred Only) as fee (Non-refundable) and Rs.5,000/- (Rupees Five Thousand Only) (Refundable) in the Form of D.D in favour of ICAR Unit A/c, IIRR HYD” as EMD for participating in the Auction.**
