

Original documents will be verified at the time of appointment. If any candidate is found to have submitted false claims at later stage, their candidature will be summarily rejected.

Terms & Conditions

- 1. The above post is purely temporary initially for one year it may be extendable based on the performance and fundavailability.
- 2. If we receive large number of applications, the applications will be shortlisted for interview based on additional qualifications and experience.
- 3. Original documents will be verified at the time of interview.
- 4. The interview of eligible, short listed candidates will be held virtually on the prescribed date and time, which will becommunicated by mail.
- 5. The candidates will have to send a soft copy of the filled in application form duly signed as per the format annexed, along with the self-attested scanned copies of the original documents of the qualifications and a recent photograph pasted onto the scan application as a **Single PDF File.**
- 6. The selected candidate will be required to produce all the original documents and medical certificate at the time of joining.
- 7. Only the shortlisted candidates would be interviewed.
